Preamble

The Memorandum of Understanding (MoU) is entered into by and between N.K.T. National College of Education for Women, (Autonomous), Triplicane, Chennai - 600 005 and ExNoRa International Foundation, Chennai. This Memorandum of Understanding is executed at Chennai on 1st July, 2022 through the Chief functionaries of the parties.

- I **N.K.T. National College of Education for Women** is situated at the heart of the Chennai city at Triplicane. The College is built in an area of 3.06 acres, where a model school is also housed. Established in the year 1966, by Sriman N.K Thirumalachariar, a visionary & a philanthropist, it has evolved into a well established College catering to the teacher education needs of women from all sections of the society. The College offers both graduate and postgraduate courses in Education with Autonomous status awarded by the University Grants Commission in the year 1988. In thirty years after Autonomy, the College has grown upright to great heights as an institution of higher learning in Education. N.K.T. National College of Education for Women has also fallen in line with to NAAC peer team evaluation and it was awarded a five star status in the first cycle and awarded A Grade with CGPA of 3.26 on a 4 point scale in the second cycle. In its continuous striving for excellence over five decades in achieving position '*Second to None*', the institution has been successful. The College, in this 56th year of its existence, with 34th years of autonomy, remains fully aware and committed to its mission of empowering young women student teachers to face life and its multifarious challenges at both personal and professional levels.
- II **ExNoRa International Foundation, Chennai** has established links with the Department of Accounting and Finance in promoting awareness on sustainable environment, conservation of natural resources & wild life and all environment issues among college / school students, local community and further introducing new ventures in the protection of Mother Earth.


The following agreements were made between the PARTIES:

1. The active participation in every stage of designing and implementing activities concerned to the Environmental Issues, Conservation of Natural Resources and Wild Life decided mutually by the parties as and when required.
2. THE SECOND PARTY will have the following ROLES AND RESPONSIBILITIES
 - ✓ Motivation and training programmes to students and faculty to develop awareness on various Environmental changes for better waste management and Environmental sustainability.


- ✓ Development of newer processes as and when time change to enhance the interest of students.
 - ✓ The SECOND Party will give technical support and act as a consultant, designing the programmes, support the annual plan of action.
 - ✓ Guiding the students in carrying out awareness programmes, internship and projects related to all environmental issues.
 - ✓ Identifying opportunities for conducting and organizing Seminars, Symposium, Conferences, Exhibitions and Workshops on special days like World Environment Day, World Ozone Day, World Nature Conservation Day, etc..
 - ✓ Collaborative outreach program in rural schools and in villages.
3. "THE FIRST PARTY" will adequately support the activities financially and in all possible ways to enable the "SECOND PARTY" to discharge their above mention role and responsibilities effectively.
 4. The Annual Plan of Action in month wise will be planned for every year and finalize by BOTH the parties. The major activities will be held under banner of BOTH the Parties.
 5. THIS MEMORANDUM OF UNDERSTANDING, both partners affirm their commitment to carry out the activities and achieve the objectives mutually agreed upon.
 6. THIS MEMORANDUM OF UNDERSTANDING will be expiring in TWO Years as per date if both sides need an extension or termination, the FIRST party sends a requisition by written, however the assignment taken will be completed at any cost.
 7. The FIRST Party will maintain minutes, half yearly and annual detailed reports with proper documents and will be able to produce/ share at any time of need.


8. In case of implementing high level technical project SECOND PARTY will introduce or refer trusted consultant to FIRST PARTY.


