CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely **N.K.T. National College of Education for Women, No.21, Dr. Besant Road, Triplicane, Chennai-600005 Tamilnadu** vide SRC (NCTE) order no. F.TN/SRO/NCTE/2001-2002/8506 dated 05.11.2001 for conducting M.Ed. course of one-year duration with an annual intake of 20 students from the academic session 2001-2002. The intake of M.Ed. course was enhanced on the basis of NCTE (amendment) Regulations, 2010 from 20 to 25 students on 13.04.2010 from the academic session 2010-2011.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 25.06.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. courses of two years duration with an annual intake of 50 (One unit) from the academic session 2015-16.

3. **AND WHEREAS**, the case of the institution for final consideration of RPRO compliance issued vide order No.F.SRO/NCTE/AOS00363/M.Ed./TN/2015/66204 dated 31.05.2015 with an annual intake of 50 students (one unit) from the academic session 2015-16 was placed before the SRC in its 395th meeting held on 27th - 28th 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **N.K.T. National College of Education for Women, S. No. 870/4 & 870/2, Ward No. 89, Zonal No. 06, Triplicane, Chennai - 600005 Tamilnadu** for the following courses: -

- (i) **B.Ed - 4 units (50 students in each unit).**
- (ii) **M.Ed- 1 unit of 50 students.***

4. **NOW THEREFORE**, w.r.t compliance of RPRO for M.Ed. programme, this order is issued permitting the institution i.e. **N.K.T. National College of Education for Women, S. No. 870/4 & 870/2, Ward No. 89, Zonal No. 06, Triplicane, Chennai - 600005 Tamilnadu** run by Under the Management of **Sriman N.K. Thirumalachariar National Education Society (Regd.) Chennai (Autonomous)** for Continuation of recognition for M.Ed. programme for 1 units of 50 students subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

6. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

7. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter;
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
9. The institution shall make available the list of students admitted on its official website.
10. The institution shall fill the information on GIS Portal on the NCTE Website.
