## RULES AND REGULATIONS

- The End Semester-III Theory Examinations Commences from 30th November 2022
- Timings for the Examination is from 10.00 a.m. to 11.30 a.m./ 10.00 a.m. to 1.00 p.m.
   (Forenoon) as per the requirement of duration of Examination stipulated for each course.
- Students must enter the Examination Hall only with their ID Card and Hall Ticker, otherwise they
  will not be permitted to enter the Examination Hall.
- 4. Students will not be allowed to enter the Examination Hall after 10.30 a.m. (Forenoon Session)
- No Student can receive the Question Paper before occupying her assigned seat in the Examination Hall.
- Mobile phones are strictly not permitted inside the Examination Hall. Students found with mobile
  phone will be sent out of the Examination Hall and will not be allowed to continue writing their
  examination.
- Students are prohibited from bringing/carrying into the Examination Hall any book, material or any matter of description.
- Any communication by a student with other student in Examination Hall will be viewed seriously
  and subjected to severe punishment.
- Students on completing the examination can leave the Examination Hall not before 11.00 a.m. (Forenoon session)

- 10. The College views malpractice of any kind very seriously. Any student found to be directly or indirectly involved in malpractice of any kind during examinations will be subject to substantial penalties and the following steps will be taken:
  - The students will be sent out of the Examination Hall by the Invigilator. The evidence of the malpractice will be analysed by the Examination Committee along with the Invigilator who detected the malpractice.
  - ❖ If the student is found guilty. "Zero" marks will be given for the course in which the student was found to have committed malpractice during that Semester.
  - . Her Hall Ticket will be seized and she will be debarred from writing all the subsequent examinations during that Semester and marked "Absent" for the rest of the Examinations.
  - . The Parents of the student will be informed to come in person to meet the Examination Committee. The Consequences of the malpractice will be explained to the parents by the Committee Members.
  - The Parent will have to give an undertaking stating that his/her daughter will not indulge in any kind of malpractice in future.
